FIRST AMENDMENT OF DECLARATION OF
CONDOMINIUM OF HIGHLAND PLACE
OFFICE CONDOMINIUM

THIS AMENDMENT OF DECLARATION OF CONDOMINIUM, is made this 11th day of March, 1988, by BELMOR CORPORATION and W. A. MAXWELL, INC., both North Carolina Corporations with their principal places of business in Fayetteville, Cumberland County, North Carolina, doing business under the name of "HIGHLAND PLACE PROJECT, A JOINT VENTURE", herein called "Declarant", pursuant to provisions of Chapter 47C of the North Carolina General Statutes, entitled the "North Carolina Condominium Act".

W I T N E S S E T H:

WHEREAS, Declarant is the owner of all Phase II of Highland Place Office Condominium as shown on a plat duly recorded in Condominium Book 2, Page 186, Cumberland County Registry, which Phase specifically includes Buildings 3 and 7 and the driveway, parking areas, sidewalks appurtenant thereto; and,

WHEREAS, Declarant is the developer of the Highland Place Office Condominium and has caused to be recorded a certain "Declaration of Condominium of Highland Place Office Condominium" in Book 3350, Page 659, Cumberland County Registry, which "Declaration" initially applied only to Phase I of Highland Place Office Condominium; and,

WHEREAS, Article IV, Section 4.1 of the aforementioned Declaration provides that Declarant may add additional real estate to the Condominium. Other sections of that Article pertain to the Declarant's right to add additional real estate; and,

WHEREAS, Declarant desires to have Phase II of Highland Place Office Condominium formally added to the Highland Place Office Condominium Project pursuant to the aforementioned provisions of the Declaration.

NOW, THEREFORE, pursuant to the authority contained within the Declaration and Chapter 47C of the North Carolina General Statutes, Declarant declares that Phase II of Highland Place Office Condominium as described above is hereby annexed into and formally made a part of the Highland Place Office Condominium and is hereby subject to all of the provisions, terms and

conditions of that certain "Declaration of Condominium of Highland Place Office Condominium" recorded in Book 3350, Page 659, Cumberland County, Registry.

Pursuant to Article VI, Common Elements, of the aforementioned Declaration, the percentage of undivided interest in the Common Elements appurtenant to each Condominium Unit will change by the inclusion of Phase II in the Condominium. The percentage of undivided interest in the Common Elements is as shown on the attached "First Amendment of Exhibit 'C' To Declaration of Condominium, Highland Place Office Condominium" of the aforementioned Declaration of Highland Place Office Condominium recorded in Book 3350, Page 659, aforesaid Registry.
